## Bloodstock Open Air 5th – 9th August 2026 Catton Park, Walton on Trent

It's that time of year again with the Bloodstock festival due to take place in a few weeks' time. For those of you who are not aware of Bloodstock, this will be our 25th year Anniversary, with a licenced capacity of 20,000 attendees, most of which camp for the weekend.

As always, we would like to provide you with some useful information to help you get through the festival weekend with as little disruption as possible.

The festival site build will commence on Tuesday 28<sup>th</sup> July and the site will be totally cleared by Friday 14<sup>th</sup> August.

The campsite opens its doors to festival goers on midday Wednesday 5<sup>th</sup> August. We still have 4 stages at Bloodstock – The main outdoor stage which is the Ronnie James Dio stage opens 6pm on Thursday this year to celebrate our 25<sup>th</sup> Anniversary. The Sophie Lancaster Stage is situated inside a Big Top and opens Thursday evening at 5pm. The New Blood Stage is our 3<sup>rd</sup> stage inside another Big Top which opens on Friday and the EMP Acoustic stage is our fourth and smallest stage inside a tent in the main arena which also opens on Friday.

Leading up to and during the festival we will continually work closely with the District Council, and with a noise consulting agency, to ensure that all noise levels coming from the festival are within the legal limitations for the area. Professional noise checks will be carried out throughout the duration of the festival.

We intend to carry out a test of the sound system on Thursday 6th, to be overseen by the Environmental Health Departments' Pollution Control officer. This allows us to set levels in the Arena that will not impact unduly on the surrounding areas.

It may help to bear in mind change in weather conditions can also affect noise levels, therefore on one day you may hear very little if anything from the festival site and on another day, you may think it's louder. Onsite noise levels will not have changed – low lying cloud and wind carries sound further than if it were a clear day with little or no wind at all. Also, if its very hot weather, heat carries sound much quicker than on a cooler day. Therefore, we are beholden to the elements to an extent.

## **SECURITY & CROWD MANAGEMENT**

We continue to invest heavily in our security and crowd control operation and are once again employing the services of an industry leading crowd Management company. We will have security operating 24 hours a day from the first day of our build until we leave site on Friday 14<sup>th</sup> August.

## **SITE LAYOUT**

The festival site will be a very similar layout to last few years, with the weekend Public Car Park situated on the field directly across the road from the main Catton Hall building, with the festival entrance approximately 900 metres down the road directly opposite the Round House. The VIP car parking will once again be in the field directly across the road from the production entrance. The Public Day Parking field has moved this year across the road from the festivals production entrance. All Campervans are parked in the field directly next to the Catton House.

## **TRAFFIC MANAGEMENT**

### CUSTOMER TRAFFIC

As you'll likely be well aware, there are ongoing major roadworks across Tamworth, Burton and surrounding areas throughout the summer period again this year which will very likely impact traffic travelling to the festival site. Therefore, following the great success of the last 2 years, we are continuing to split our event traffic arrival over 2 days (Wednesday and Thursday) to help relieve traffic congestion as much as possible.

However, even with adding this extra day for arrival, disruption to the road network is inevitable at certain times during the festival weekend. So please be aware that during Wednesday and Thursday, there will be more vehicles on the road than normal. However, we go to great lengths to minimise this disruption as much as possible. If vehicles breakdown on the road en-route to the festival, this can increase road congestion for a short time until the vehicle is recovered. We will have recovery vehicles on standby from Wednesday to Monday in case of such an event.

All campers must vacate the campsite by 13:00 Monday 10<sup>th</sup> August. This means that the highest volume of traffic coming away from the festival can be expected between Sunday night and Monday morning.

Due to the continued traffic management measures on Chetwynd Bridge, we will once again put in place additional measures in an attempt to alleviate the effect for both existing road users and our own event traffic. However, we have to prioritise the A38 and therefore local traffic travelling northbound on the A513 to the A38 will experience delays and we would encourage those who can, to use alternative routes especially during our peak traffic periods.

Once again, we will have temporary public crossings with temporary traffic lights in place at 3 locations on the main Catton Road to allow festival goers to cross the road safely from the main public car park, the VIP car park and the crew campsite. So please be conscious of the public crossings if travelling along the road from the A513 (A38). PLEASE NOTE –**There will be a temporary speed restriction to 30mph on the main road along Catton Park and Catton Hall from Monday 27<sup>th</sup> July to Friday 14<sup>th</sup> August. PLEASE DRIVE SLOWLY.**

## BUILD AND BREAK TRAFFIC

Our Build and Break traffic management plan worked successfully for the third year running to accommodate the loss of being able to use Chetwyn Bridge due to the new 7.5 TONNE weight and width restrictions. This was historically the main route in for most of our heavy good's traffic as well as our live event traffic. However, this restriction does not affect our live event traffic.

**We have put together a build and break traffic schedule that we will make available to all local parish councils no later than 2 weeks before our build starts. This will be emailed to the following Parish Councils to make available on their websites should you wish to view.**

Alrewas Borough Council, Barton Parish Council, Coton in the Elms Parish Council, Drakelow Parish Council, Netherseal Parish Council, Overseal Parish Council, Rosliston Parish Council and Walton Parish Council.

Please bear in mind that this schedule is a guideline only. We will endeavour to keep all build and break traffic to this schedule but roadworks around Staffordshire may cause slight delays to some of these deliveries.
